SECOND-HAND UNIFORM POLICY

CONDITIONS FOR ACCEPTING SECOND-HAND UNIFORMS FOR RE-SALE

1. Items are accepted on a consignment basis. Consignors will be given a receipt for goods left for re-sale. Payments will be made to consignors only when all the goods have been sold. Consignors will be notified when all goods are sold. Payments to consignors will be made by electronic funds transfer only in accordance with current P and C payment schedules.
2. **The P and C require a non-refundable payment of \$2 per item, regardless of value, upon receipt of your goods to sell. No other commission applies.**
3. Items may be donated for sale. No payment or receipt required.
4. **There is no facility available for store credit.**
5. All items must be in excellent condition and freshly cleaned. Items found to not be in sale quality condition may be rejected immediately, including items that require mending. If this occurs you will be notified and have the opportunity to pick-up your items. Items will be assessed by the convener and one other member. Items will not be assessed immediately as this takes time and will be done after closing.
6. **Items may only be dropped off for sale during opening hours and will only be accepted with a signed form and a receipt will be given. Item prices will be set by the P and C.**
7. Whilst all care will be taken by the Uniform Shop staff and members of P and C, no responsibility for loss, damage, fire or theft of garments will be accepted.
8. **If items are not sold within 6 months from date of drop off you will be notified and have the opportunity to pick-up your items or donate them to the clothing pool in the office.**
9. The consignors may reclaim any unsold items from the Uniform Shop at any time within the 6 month timeframe.
10. **The P and C will not accept hats, socks, bags or hair accessories for re-sale. Only recently purchased uniform items that originated from the uniform shop will be accepted, for example, formal shirts, formal shorts, formal dress, V-neck jumpers, knitted jumpers, blue and gold polo's, blue shorts etc.**
11. The P and C retains the right to refuse any item that does not comply with the above criteria or current uniform guidelines. This policy is subject to change as per the departmental guidelines.

SECOND-HAND UNIFORM POLICY

CONDITIONS FOR SALE OF SECOND-HAND UNIFORMS

1. Parents purchasing second-hand uniforms must be made aware that they are sold AS IS. That means they are not in brand-new condition and may or may not have been altered prior to being handed in for re-sale.
2. **Whilst all care is taken to ensure that the sizes are correct, the P and C cannot guarantee this, therefore you should try the garment on your child before committing to buy it.**
3. Second-hand uniforms are sold with the understanding that they are not in any way, shape or form, brand-new. These items have been pre-worn, pre-washed and possibly altered to accommodate the original purchaser.
4. **All care is taken to ensure that the item you are buying is in reasonable condition; however, it is up to the purchaser to inspect all items before purchase to avoid disappointment.**
5. Under no circumstances is the P and C or uniform shop staff responsible for any alterations or repairs made to second-hand items.
6. **All second-hand uniform items offered for sale must meet strict criteria and are priced accordingly.**
7. Lay-by is not available for second-hand uniforms.
8. **Buying second-hand uniforms must be done carefully as no returns or refunds are available.**
9. All items offered for re-sale are the property of the consignor not the P and C.
10. **This is a service provided to the school community by the P and C on behalf of parents on a consignment basis.**
